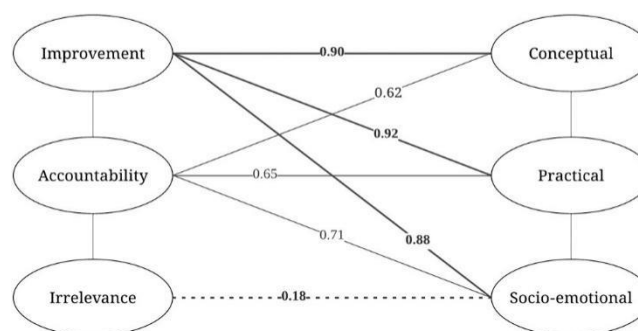


Figure 1. Sample figure caption (10 pt, italic, below figure)

For two authors: (Sharma & Kumar, 2021).

For three or more authors: (Sharma et al., 2020).

Journal Article Format:

Author, A. A., Author, B. B., & Author, C. C. (Year). Title of the article. Journal Name, Volume (Issue), Page range.

Formatting Rules:

- Only journal articles should be included in the reference list.
- Article titles should be in sentence case.
- Ensure all in-text citations are listed in the reference section.
- All reference must be in 11 font size .
